

CSR Annual Action Plan FY 2022-23

The notification of changes in the Companies Act 2013, on 22nd January 2021, has called for an annual action plan in pursuance of the CSR policy to be formulated and recommended by the CSR Committee for approval by the Board. Further, it stated that the Annual Action Plan shall include the list of projects or programmes approved, the manner of execution of the projects, modalities of utilization of funds, implementation schedules, monitoring and reporting mechanism and details of the need and impact assessment if any undertaken.

The below listed projects are on-going programmes which would continue in FY 2022-23 as a part of the overall NSE Group CSR activities which are undertaken under the common group CSR policy. Thus, their outlay is part of the overall CSR expenditure to be incurred in FY 2022-2023.

Note: The above annual plan gives the list of earlier approved but currently ongoing projects. These will continue to be undertaken in FY 2022-23. The plan maybe revised depending on various factors such as ground assessment, capacity of local partner agencies, natural disasters and calamities, events beyond the control of the stakeholders etc., that necessitates course correction.

The projects will be implemented by NSE Foundation, a Section 8 company incorporated to undertake the CSR obligations of the NSE Group companies falling under the mandate of the Sec 135 of the Companies Act, 2013.

Additional projects shall be approved by the CSR Committee & Board during the financial year so as to meet the CSR obligations. The Board on recommendation of the CSR Committee may alter the above annual plan of action at any time during the financial year.

Monitoring & Reporting Mechanism*: The regular programmatic and financial monitoring and evaluation of the programmes are conducted by the independent Project Monitoring and Evaluation (PME) agencies appointed for the purpose. To review the status of the programme activities and expenditure, the PME agencies conduct periodic reviews which include field visits. The programme is assessed on key indicators, and the PME agency suggests modifications in programme design, adoption of best practices, efficient deployment and utilisation of resources, templates for reporting, sustainability, and exit strategies. Based on the income and expenditure statement, after accounting for deficit, surplus, etc., a report and recommendation by the PME agency is made for further release of funds.

Need/Baseline Assessment:** The empanelled PME agencies conduct due diligence of the project proposal which includes refinement of the programme methodology, optimisation of the cost etc. before recommending the proposal. For most projects, data is collected from secondary sources at the proposal stage. On approval of the project, baseline activities are conducted by the on-ground partner agency and refinement in programme implementation plan is incorporated.

Impact Assessment: Thirteen (13) projects across various core focus areas concluded their programmatic activities in FY 2020-21 and impact assessment for these projects was initiated. Due to the COVID pandemic, there had been a delay in conducting field visits, direct interviews with beneficiaries and focus group discussions with the community and other stakeholders. The summary of the findings would be placed before the CSR Committees and Boards. The summary of the assessment and the link of the completed assessment reports will be provided in the Board's report.
