Business **Need**

The client, a prominent financial service provider, sought a dedicated solution for their data analytics and reporting requirements. The primary objective was to consolidate loan data and generate comprehensive reports for stakeholders. However, the loan data received from various financial service companies presented data quality issues.

To enable effective analytics and reporting, it was crucial to address data deduplication and cleansing. The solution needed to be agile, catering to ad-hoc data requirements promptly. Moreover, the solution was expected to empower the identification of trends within the loan data.


Business **Challenge**


The primary challenge lay in processing billions of records to ensure regulatory compliance and enable effective investigations and surveillance. Complex compliance, investigation, and


surveillance requirements necessitated the correlation of data across multiple silos. Furthermore, the volume of data involved required robust data discovery and analytics capabilities.

Creating interactive dashboards with row/column level security, enabling multiple stakeholders to access relevant data.
